**Final slip payments are non-refundable after May 1, 2024.**



## Conditions and Regulations

### Silver Harbour Marine Resort

- Marina grounds, boat basins, washrooms and showers may be used by patrons and their guests for designated purposes but must be kept clean and orderly.
- Patrons are responsible for their children and guests.
- All pets must be kept under control at all times and waste properly disposed of.
- Operation of vessels within the harbour must comply with safe boating regulations, and environmental regulations and with full consideration of other boaters. The speed limit of 5 km/h (No wake) shall be observed within the harbour.
- Any persons using any Silver Harbour Marine Resort facilities, whether the same be a boat owner, his/her servants, agents or invitees do so at their own risk. Silver Harbour Marine Resort shall not be responsible for any damage or injury sustained by such person.
- All boats, RV's, trailers, masts, and cradles at/on Silver Harbour Marine Resort's premises, or being hoisted, lifted, handled by Silver Harbour Marine Resort's servants or agents shall be at the OWNERS' RISK and Silver Harbour Marine Resort shall not be responsible, under any circumstances, for any loss of/or damage caused or sustained by such boats, RV's, trailers, masts or cradles whether the same be caused by the negligence of Silver Harbour Marine Resort, its servants or agents or otherwise.
- A boat or RV owner registered as user of a designated slip or site will be the sole user and will not lend, rent or permit that slip or site to be used by anyone else without prior approval and arrangements made with management.
- The boat or RV owner/owners, or patrons shall be liable for any loss, damage or destruction caused by negligence of Silver Harbour Marine Resort's property.



- Vessels moored or RV's on sites at Silver Harbour Marine Resort shall not be used for charter or rental without prior approval of management.
- All boat and RV owners must obtain permission from Silver Harbour Marine Resort to have any third person perform work or services on Silver Harbour Marine Resort property.
- Boat and RV owners who have their boats /RV's listed privately for sale are not permitted to use any Silver Harbour Marine Resort property or facilities for signage advertising (except onboard signage) unless approved by management and all showings must be accompanied by the owner. Also, no boat brokers or salespersons are permitted to use Silver Harbour Marine Resort facilities unless approved by management.
